Cllr Kay stated that he was not seeking re-nomination. He thanked all Councillors for their support throughout his 3 years of service, in particular Cllr Penny for his loyalty, faithfulness and friendship throughout the year as Deputy Mayor. He also wanted to record particular thanks to his wife, Michelle for her commitment, dedication, loyalty and attendance at Civic events.

The Town Clerk presented Cllr Kay with his Past-Mayor medal, which was supported by a unanimous round of applause.

Cllr Penny thanked Cllr Kay for his service, loyalty, dedication and commitment. Drawing particular attention to his leadership - with the support of his wife Michelle, and the significant steps forward through his pro-active approach. In particular, preparation of the 4 Year Plan, development of Bell's Field Project, the establishment of the Tourist Information Centre (TIC), and the progression of the Twinning with St. Hilaire de Riez, in the Vendee France from the early stages of an idea through to its sustainable establishment some 12 months on. Also the exceptional amount of £15k raised for the Mayor's nominated charities and good causes. Cllr Penny, on behalf of the Council, made a small presentation to Cllr Kay and flowers for his wife, Michelle acknowledging the significance of her role alongside and in support of Cllr Kay.
