384. To agree priorities for Coleford Town Council in relation to Climate Change and the Environment

Cllr. S Cox presented his Summary Report, following attendance, along with Cllr Elsmore, and Drury, at the FoDDC Climate Action Day, on 7 October 2020, and stated that it had been a very positive, constructive, interactive, and informative workshop event. After further discussion, it was recognised that the issues were vast and urgent, with unanimous agreement that the town council needed to start 'scoping' its activities, and priorities, as a demonstration of its commitment. In turn, as an urgent first stage, it was proposed that the town council establish a new Environment Committee, to determine and drive forward, environment issues to reduce the impact across the parish of Coleford. It was also proposed that a working group should be scheduled, within the month, to consider the range of issues, to focus on the new Committee's aims, objectives, role, remit, and responsibilities. This work, to then inform the inaugural meeting of the new Environment Committee, in the first week of December, to enable the formalising of a Committee Framework document, for Standing Orders.
