#### 498. To agree to the appointment of a Town Centre Manager (TCM)

Cllr. Penny reported that, the only candidate scheduled for interview, for the TCM post, had declined, due to having secured alternative employment, in advance of the interview for this post. In turn, it was proposed that this item be deferred back to Regeneration committee, for further consideration, re: next steps.

On being put to the vote it was unanimously agreed.

## 499. To receive an update re staffing matters

Cllr. Penny summarised the position of the Assistant Clerk's outstanding leave allocation, in light of his allocation being linked to the end of the 31 March 2021 Financial Year, and the fact that, with previous agreement, to carry over exceptionally, 5 days allocation, and some leave now having been taken, there is still .66 of a day allocation to take within this year's allocation. After some discussion, it was proposed that this .66 allocation is made up to a whole day, and to be 'tagged' on to the Easter weekend holiday.
