### Report from David Wilson Homes (DWH), as follows:

They are aware of the concerns of the LEAP.

- a. The profile of the green area is not to specification (a bit high), to be dealt with.
- b. The position of the exit pipe is in the correct position.
- c. The amount of water entering the stream from Owen farm is to be checked against calculation.
- d. The exit of water to Albert Road appears to be correct.
- e. They are awaiting the decision of FoDDC as to moving the LEAP.

### DWH will be attending to these problems and "time will tell".

They will look into the position of lighting on the estate, as to the specification in the plans, as to who will be responsible: GCC or, if, Two Rivers.

Water at the top of the estate from Owen farm and Cemetery has been addressed.

They have installed hand rail and Bus Shelter will be provided soon.

Concern was mentioned re: exit from estate on to Staunton Road.
