No evidence is given, as to how it is to be realistically achieved Re: Bus Routes: No evidence is cited as to how bus routes are to be improved, nor, for example, engagement with the bus company to provide greater services along Lower Lane, where the No 35, is only routed twice in the day. There is no cycle way provision, and we note GCC Highways, interest in improving cycle networks, which we share.
