- 4. The minutes of 16 September were noted The minutes were noted, and approved.

5. To raise matters arising from the minutes of 16 September

Item 5: Cllr. Drury sought an update on the Lidl site, in respect of tree planting, and a site meeting was proposed for next week (4 November) with Brian Watkins, Cllrs Elsmore, Drury, Barnham, Walt Williams and Caroline Silverwood

7. To make recommendation regarding working group action plans

Cllr Elsmore summarised the four sets of minutes, and summary table (already circulated), and expressed thanks to all those that had been involved with these 4 groups; in particular, in light of the action plans that had emerged. Various projects were discussed, and the associated funding streams that might be necessary. It was recognised that it was now time to start driving this work forward, tin light of the effort now
