

Regeneration Committee Wednesday 22 January 2020 Minutes

- 1. Apologies were noted from Cllrs Kay & Allaway-Martin, B Watkins GCC Highways
- 2. There were no declarations of interest on items on the agenda
- 3. There were no dispensation requests
- 4. The minutes of 16 December 2020 were agreed
- 5. There were no matters arising from the minutes of 16 December 19

6. To take comment from the public forum

Mrs Taylor requested to know if any progress had been made with the installation of the lime trees on Old Station Way. She was informed that it was within the system at the FoDDC

7. To hear feedback re the HAZ grant application.

Mr Stuart gave an explanation of the process that the council HAZ grant went through and stressed the independent nature of assessing the applications. Pointing out that one of the main criteria was the deliverability of the project within the 4 year time period.

The Council grant was les strong in its partnerships with other local authorities particularly GCC Highways which gave no firm commitment to the projects. This made the application vulnerable on its deliverability.

The monies available had been allocated to the 10 projects chosen so there was no opportunity to reassess the application.

The way forward could be to strengthen the relationships with all partners and to seek other funders are present the application to meet their specific requirements.

The FoDDc has a statutory responsibility to assess the vulnerability of the conservation area and if Coleford town was deemed to at risk this would bring the town council to the attention of Historic England. The assessment would take place in the next few months. The criteria for the assessment are the condition of the buildings, the vulnerability of the management and the trend. It was agreed that Ms W Jackson & Mr R Morgan would raise this with the FoDDC. Ms Jackson would circulate the assessment process of the conservation area assessment

9. To have an update on the progress with the cycle path project

It was noted with regret Mr B Watkins inability to attend this meeting. It was agreed that he should be chased for the costings of the forward plans previously requested.

That Cllr Allaway- martin is asked to sit on this committee as a representative from Glos County Council and that a request is made for a representative from GCC Highways forward planning department is also invited as a permanent member of the committee



10. To have feedback on the meeting with hauliers re traffic routes through Coleford
